- **Please note** your quilt entry must have a hanging sleeve. Please stop by Evergreen Church Comfort Quilters Room 307 Upstairs any Thursday from 11-1:30. Comfort Quilters will show you how to apply a permanent Hanging Sleeve if you wish, OR will show you how to apply a temporary pin-on Hanging Sleeve.
- Each quilt must have a label and be in a pillow case when dropped off. Please put your name on the pillowcase.
- Quilts must be "handmade" no mass produced commercial quilts please. Maker unknown quilts are acceptable.
- Quilts must be clean, odor and pet hair free.
- Entry deadline is September 15, 2018

- You may call Laura Bosma at 404-667-1403 for other arrangements if no email access.

- Quilts must be delivered to Evergreen Church located at 400 Windgate Road, Peachtree City, GA on Thursday, October 11, 2018 between 3:00pm and 5:00pm.

- A completed Hold Harmless Agreement must accompany each quilt at drop-off.

- You will be given a receipt at the time of drop-off. Please bring it with you when picking up your quilt.

- Items must be picked up after the show on Saturday, October 13, 2018 between 6pm and 7pm.

- Please consider volunteering to help at our A Stitch in Time Quilt Show. This is a Community Outreach Event Hosted by Evergreen Church.

In the event Evergreen Church, Evergreen Church Comfort Quilters, Quilters Guild of the Southern Crescent, and Common Threads Quilt Guild is named as defendant in any action covered by this indemnification and hold harmless agreement, I agree to hold Evergreen Church, Evergreen Church Comfort Quilters, Quilters Guild of the Southern Crescent, and Common Threads Quilt Guild harmless of any liabilities thereon.

If you are not covered by a Homeowners insurance policy, it is strongly suggested you purchase some kind of liability insurance to cover you, your quilt(s) and your equipment.
